On behalf of the Vice Chancellor, Nalanda University, Rajgir, Bihar, you are being invited to submit quotation providing and fixing of street light in Ajatshatru Vihar of Nalanda University at Rajgir, Bihar as per the Schedule of Quantities enclosed herein below as Annexure I and as per the Terms & Conditions specified here under:

1. Last Date & Time for submission of quotations: 11th July 2016, 1500 Hours
2. Date & Time for opening of quotations: 11th July 2016, 1530 Hours.
3. Venue for Submission & opening of Quotations: Nalanda University, At – Chhabilapur Road, Rajgir, District–Nalanda, Bihar – 803116.
4. Earnest Money Deposit: Rs. 26,000/- (Rupees twenty six thousand only) through DD from any scheduled Bank in favour of “Nalanda University”, payable at Rajgir.
5. Tender processing fee @INR 1000/- (One Thousand Only) through DD from any scheduled Bank in favour of “Nalanda University”, payable at Rajgir.
6. Performance Security during execution @ 5 % of the tendered amount through DD from any scheduled Bank in favour of “Nalanda University”, payable at Rajgir or FDR or BG (Format as provided in CPWD works manual). Successful bidder shall submit performance security immediately (within 5 days) after issuance of LOI.
7. Security guaranty during defect liability period @ 2.5% of tendered amount shall be deducted from running bills and it may be released on submission of FDR/BG of requisite amount. On successful completion of each year the security amount shall be release on prorated basis.
8. Contractor:
The Contractor shall mean the individual, firm or company, whether incorporated or not, undertaking the works and shall include the legal personal representative of such individual or the persons composing such firm or company, or the successors of such firm or company and the permitted assignees of such individual, firm or company.
9. Mode of Submission:
 - a. The quotation may be sent by post or may be dropped in the Tender Box of the Nalanda University, Rajgir, placed in the Reception, on or before due date & time of receipt of offer as

indicated above. Quotations which do not reach this office latest by 3:00 PM on the due date, will not be opened and will be summarily rejected. The Nalanda University will not be responsible for any delay in receipt of quotation by post whatsoever may be the reason.

The Schedule of Quantities as per Annexure I shall be duly filled for the rates and signatures affixed wherever required. The sealed cover shall be super scribed with "QUOTATION FOR PROVIDING AND FIXING OF STREET LIGHT IN AJATSHATRU VIHAR OF NALANDA UNIVERSITY, RAJGIR, BIHAR". The quotation shall be signed by a person legally authorized to enter into commitment on behalf of the Bidder. Bidder shall submit Power of Attorney in favour of the person who is authorized to enter into commitments on behalf of the Bidder. If the bidder is an individual, the quotation along with the NIQ shall be signed by such individual above the full type written name and current address.

Copy of Certificates of PAN card, TIN/VAT registration and Service Tax registration is to be submitted along with the quotation.

NALANDA UNIVERSITY will not be bound by any Power of Attorney granted by the Bidder or changes in the constitution of the firm made subsequent to submission of the bid or after the award of the contract. The University may, however, recognize such Power of Attorney and changes after obtaining proper legal advice, the cost of which will be borne by the Bidder.

The cancellation of any document such as Power of Attorney, Partnership Deed etc. should be communicated by the Bidder to the NALANDA UNIVERSITY in writing well in time, failing which NALANDA UNIVERSITY shall have no responsibility or liability for any action taken by NALANDA UNIVERSITY on the strength of the said documents.

Should the Bidder have a relative or relatives in NALANDA UNIVERSITY or one or more of its shareholders are a relative or relatives of the shareholder(s) employed in a superior capacity in NALANDA UNIVERSITY, the relevant authority inviting the quotations shall be informed of the facts at the time of submission of the bid, failing which the bid may be disqualified or if such fact subsequently comes to light, NALANDA UNIVERSITY reserves the right to take any other action as it deems fit in accordance with any applicable Law, Rules, Regulations of the like in force.

10. Warranty:

For luminaries and lamp/CFL at least 1 Year or as per OEM which ever will be on later date.

Cable and wires: Minimum 1 year or as per OEM which ever will be on later date.

Metals and Pole/Pipes: Minimum 1 year or as per OEM which ever will be on later date.

Feeder Panels and MCBs: Minimum 1 year or as per OEM which ever will be on later date.

The makes and models shall be decided by the Engineer In-Charge (Electrical) and contractor will seek approval before supply. Only reputed makes shall be supplied. During the warranty period, if material/items will not be repaired/replaced within 48 hrs then University may replace/repair it and the requisite amount shall be recovered from security deposit.

11. Validity of Quotations:

The offer shall be kept valid for a period of 120 days (Ninety days) from the date of opening of quotation.

12. Prices:

The Bidder should quote both in figures and in words (English) the rates for each item in the Schedule of Quantities (Annexure I). The amount for each item should be worked out and entered. The tendered amount for the work including any taxes applicable as extra shall be entered in the quotation both in figures and in words. The price part shall be duly signed and stamped on each page. Prices shall be quoted in Indian National Rupees (INR) only.

13. Billing & Payments:

The Contractor shall submit the bill(s)/invoice(s) in triplicate copy along with manuals and warranty card. The NALANDA UNIVERSITY shall release the payments within 30 Days from the date of receipt of the Bill(s)/ invoice(s) duly certified by Engineer in charge along with necessary supporting documents, if found in order. However, the sequence for releasing payments shall be as detailed below:

- a. Payment shall be released after successful completion of the works including providing and fixing of street light.

The tentative quantities are given in SOQ as Annexure-I. However the actual joint measurement of work done will be acceptable for payments of bills submitted.

14. Time Schedule:

The time stipulated for completion of works in all respect providing and fixing of street light is 30 days from issuance of letter of award. However, University is desirous to execute the work before 25th July 2016.

15. Nalanda University's Rights:

NALANDA UNIVERSITY reserves the right to accept a quotation other than the lowest and to accept or reject any quotation in whole or part, or to reject all the quotations received with or without assigning any reasons.

16. Extension Order:

Repetition of order: If required, Nalanda University reserves right to place 100% extension order or part hereof awarder work order on company subjected to the condition within one year from date of order.

17. Additional quantity other than SOQ: Nalanda University reserves right to place an extension order for any additional quantity to extent of 100% quantity of the original order on the same rates subjected to the condition within one year from date of order. However payment will be based on actual measurement of work.

18. Liquidated Damage:

If work is not completed within specified period a liquidation damage will be charged from contractor @ 0.5% per week from contractor up to maximum of 5% of contract value of tender.

19. Acceptance:

It is not binding to the University to accept the lowest or any tender. The Nalanda University reserves the right to accept or reject any offer at its option or place order with more than one supplier for full or part quantity of this enquiry without assigning any reason and the same shall be binding on suppliers unless otherwise stated in the offer. No correspondence shall be entertained on this account.

20. Disputes:

All disputes, if any, out of or in respect of this enquiry are to be settled at Rajgir or be tribunal only in any competent court situated at Rajgir, Bihar. Stated specifically to the contrary, it shall be deemed that you have agreed to all terms and conditions mentioned in the enquiry and the same shall be binding on you.
